I. Call to Order

Chief White called the meeting to order. Chief White welcomed everyone to the meeting.

II. Approval of the Agenda

Chief White reviewed the agenda. No comments were made to amend. Mr. Coyne motioned to approve. Mr. Gyurisin seconded the motion. It was unanimously approved.

III. Approval of the Minutes

The members reviewed the minutes from January 15, 2019 meeting. No comments were made. Mr. Gyurisin motioned to approve. Dr. Schulke seconded the motion. The minutes were approved unanimously.

IV. Old Business

On February 2, 2019, Ms. Chmura emailed Mr., Sherman and Ms. Price about Chief Lam being reappointed. Ms. Chmura will call the Shenandoah Co. Administrator's office. Sheriff Roper agreed to be reappointed. In accordance with the COV, a Commonwealth Attorney must be a member of the CCJB. Due to Mr. Madden becoming a Judge in the fall, this will create an opening on the CCJB.

Included in the PowerPoint handout is a slide that outlines the CCJB responsibilities as described in the Code of Virginia.

V. New Business

A. Personnel and Staff Activities: Overall everything is going well. PO Grimm will be finishing his mandatory DCJS training. Other staff have attended leadership training, human trafficking, financial crimes training and everyone has completed Redwood training for using a new test cup. PO Wineman represents ODCS at the Re-Entry Council and may begin attending the NSV SA Coalition meeting. The Learning Teams have been revamped and those changes appear to be beneficial. ODCS will have an active shoot training for this year's officer safety. It is hoped that we can have a local trainer present during Pretrial/Probation/Parole Officer week.

B. Circuit Court Risk Assessments.

At the request of Judge Bryant, ODCS is looking at providing risk assessments for bail hearing in Frederick/Winchester Circuit Court cases, excluding bail hearing were a PB 15 was the reason for arrest. Hopefully this will be implemented in late June with data collection beginning in July 2019.

C. In the packet is a report from DJCS to Gov. Northam and the General Assembly dated January 10, 2019. The report reviews the status of pretrial agencies.

D. Video Arraignment:


Investigations are very busy; YTD, Judges have completed 920 bail hearings. In FY 18, there were 843 bail hearings. Of the defendants ordered released, only 28% were released with unsecure bonds. In FY 16, it was 62% and in FY 18, it had dropped to 54%.



- **I. Pretrial active cases:** A chart of charge types for active cases was include in the handout. 65% of the pretrial defendants are being supervised with a narcotic or DWI charge.
- **J. Local Probation Review**: A chart of charge type for active cases was included in the handout. 67% of the local probationers are being supervised with a felony or misdemeanor drug charge.

K. Outcome Measures

YTD FY 19 Successful closures for misdemeanants is 69% and for felons, it is 68%.

L. Local Probation Performance Measures:

The risk assessment completion rate, 72%, and case plan completion rate, 62%.

M. Closures:

Ms. Haden questioned what does treatment failure mean? It was explained failure to complete an assessment or failure to complete treatment as indicated on the assessment. As NWCSB has an open client-drivien group, Ms. Haden asked if how this group would be determined successful or a failure. Ms. Chmura stated that the PO requires regular attendance and then would determine the number of groups that a probationer would need to attend in order to be in compliance with probation. Typically, it is between 12 and 18 groups, similar to other substance use disorder providers in this area.

Mr. Coyne asked for clarification for the manner in which DCJS considered "unsuccessful" as the categories of failures could be many: community service failure, continued drug use, substance use programming failure. Does this unsuccessful count as 3 or just 1? Ms. Chmura will consult DCJS and will run some internal numbers too. She will report back to the Board.

Included in the presentation was successful closures within charge categories. Felony narcotics charges are closed successful 65% and misdemeanor charges closed successful at a rate of 70%.

With no further business to discuss and was adjourned at 7:17 p.m.
