Cheryl,

The basicREC program is budgeted to provide before and after school recreation at all FCPS elementary schools during the school year and full day recreation at eight locations during the summer in fiscal 2021.

We have budgeted \$ 2,004,729 for basicREC program revenue in fiscal 2021.

We have budgeted \$ 1,799,302 basicREC program expenditures in fiscal 2021. These expenditures include the existing full time personnel (11 Recreation Technicians + basicREC Manager) salaries and benefits, the two proposed full time positions for fiscal 2021 (12<sup>th</sup> Recreation Technician and basicREC Coordinator) salaries and benefits, part time salaries and benefits, and all other operating expenses.

\$ 205,427 goes toward offsetting other expenses shared by all recreation programs and park facilities.

Kris,

I shared the Board of Supervisors' request to move the scheduled joint meeting between the School Board and Board of Supervisors from February 26 to February 19 with Chairman Foreman. I also made him aware of the request for a second joint meeting to be held March 4 including only elected Board members.

Mr. Foreman has since contacted each School Board member individually to gauge their interest in moving the first meeting and holding a subsequent meeting without staff present. The consensus of the Board was to keep the meeting on the 26<sup>th</sup> to allow School Board members adequate time to review my budget proposal and ask any questions they may have ahead of the joint meeting with the Board of Supervisors. With regard to the requested March 4 meeting, Mr. Foreman has shared that while the School Board is willing to consider a second joint meeting with the Board of Supervisors, the consensus is that such a meeting include both myself as Superintendent and you as the County Administrator. Mr. Foreman also noted that any such meeting would be a public meeting open to all citizens, not just elected Board members. Mr. Foreman added that School Board members remain open to one-on-one meetings with their respective magisterial district representative from the Board of Supervisors the week immediately prior to the joint meeting scheduled for February 26.

Please remind your Board that I will present my proposed budget to the School Board during its meeting at 7 p.m. on February 18 in the James Wood Middle School Library. All are welcome to attend. On the morning of February 19, I will provide you with copies of my presentation as well as an executive summary of my proposed budget to be distributed to each supervisor. I, along with the School Board, look forward to our meeting on February 26.
