Input on the budget:

I do not know that you have in place a procedure to read these before you vote so this may all be in vain, but here goes.

The lack of a professionally presented and cohesive document to review the budget from home was a great hardship. Knowing in advance that Covid 19 required you to cap attendance in the room, the county administrator's PowerPoint ought to have been put online. The county is still not thinking on its feet about the realities of life under a pandemic.

Revenue:

Absolutely go for the increase in occupancy tax at hotels. At the point we get out of quarantine, I81 will be clogged with people going to check on relatives or get to the beach. We are a key stopover point and though revenues will be done for this spring, they should climb.

As the Commissioner of the Revenue said, we would need to spend some more money on tourism development, that 1.5% gap, but we could and should. Increased visitation here puts money into our hotels and restaurants and gas stations.

On sharing revenue with the schools. Have you investigated how the schools will need/use/spend/receive funds while being closed down for months? We don't want to stint them and we absolutely need to keep our salaries competitive with (note I did not say equal to) surrounding NOVA. I would suggest you study this ASAP.

I would recommend enacting a cap of 5 cents increase but not imposing it tonight. We should fully support the schools, but we don't know what their level is.

The Tax collector has time to get the bills out.

I hope you realize that in the economic shutdown being experienced, many people might lose their homes. Do you really want to be another nail in their coffin? I would have supported the proposed increase, even though I realize that we are in this pickle because previous boards failed to take bold action when it was needed 6 -10 years ago. Expenditures:

My beginning comment, after reading the detail on the fire department fuel requests is that this is the wrong year to implement strict controls. If you insist on giving them the amount you propose, which is less than they asked for, I urge you to place the difference in a reserve account. They are likely to use more fuel this and next budget years for two reasons.

- The medical emergency when it hits Frederick County will reduce mutual aid response. Units from other counties will be fully occupied there and our vehicles will drive more.
- More trips might be expected in transporting critical Covid 19 cases to Winchester Medical Center or in evaluating patients for transport at home. More calls.

I am pleased to see you approved more fire fighter/EMS positions. I only hope it will prove enough when ours go out on quarantine or fall ill. In New Orleans more than 25% of their paramedics are in quarantine.

From my years of experience in local government, if somebody asks you for a humble tractor, they must need it. Give it to them. Don't make them use some 1919 equipment, which I've known to happen.

Airport and Detention Center expenses, and revenue from the former should reduce due to decreased flights and prisoner release per pandemic policies.

If the federal government offers any debt relief provisions, this should be pursued for school debt amelioration. I see zero analysis on the two sanitary district funds so I don't know if we are running them into the ground or funding them appropriately.

We greatly appreciate your support to the Fire and Rescue System. I wanted to make known to you my thoughts on keeping the Volunteer Budget request intact this year. We know the funds allocated to the Volunteer Companies (their budget) is a part of the Fire and Rescue Department budget. In fact, we have worked very hard to become the Fire and Rescue System. We don't want to be known as "Volunteer" and "Staff". So, any funds allocated to the Department are greatly appreciated. The greater part of the recent department budgets has focused on increasing staff to meet the current call volume. As well as providing individual equipment for the staff. With that said there are 11 Volunteer companies, each with unique challenges. Some have volunteers to respond to calls, some have volunteers to help with fundraising. The majority of Volunteer companies do not have enough volunteers of each category. Most Volunteer companies can be financially self-sufficient, with their own fundraising, for day to day expenses, until they must replace a piece of equipment. The Volunteer companies have operated mostly on a flat line of funding from the county for the past 8 years. That support funding and individual fund-raising efforts do not leave much cushion to offset from a Volunteer companies' day to day expenses to replace an ambulance (\$300,000) or fire truck (\$650,000). The support we ask for this year will help with day to day expenses while allowing for a cushion to be able to purchase new equipment or at least to secure a new equipment loan.

Frederick County remains one of the most desirable locations to live in the state of Virginia. We have access to the cities, but don't pay the city prices to live there. We have family owned restaurants in the county and Old Town Winchester, farms that are embracing the emerging agribusiness industry, along with the rivers and mountains that people drive hours to enjoy.

This area is becoming a wonderful place to raise a family. With that comes the community responsibility of quality education. Quality education does not just benefit those families with children or those parents who are teachers.

It benefits the entire community.... Childhood education forms friendships, teaches them how to be good people, and gives them a reason to come back to THEIR community to start businesses and pursue their dreams.

Dr. Sovine's proposal is in the best interest of our county.

- 1. 4% increase (\$5.2 million) for teachers, bus drivers other instructional staff. Over the last couple of weeks, if you surveyed parents who are at home with their kids, I think they would unanimously agree that the teachers, bus drivers and instructional staff deserve every penny of this raise. This increase is not making our teachers rich... it's not paying them like Loudoun County... it's paying them what they deserve and making Frederick County an attractive place to start a teaching career. We need a competitive starting salary in order to attract the best teachers to the area. Again, this is not to compete with Loudoun... We are the 2nd lowest paying county within a 30 mile radius... this is just to stay relevant in the Shenandoah Valley.
- 2. \$3.3 million for 22 classroom teachers due to enrollment growth, 5 behavioral specialists for children with unique needs, and 26 instructional assistants
 - a. The enrollment growth speaks for itself. More kids... you need more teachers. With growth you have more people paying taxes.
 - b. 5 behavioral specialists...Truth be told, family structure is so important to children, but not all children have family structure and guidance. Dr. Sovine is trying to address this issue with additional behavioral specialists. Some families, for better or worse, rely on the schools to raise their children. If we don't provide the support, and they're not getting the support at home, what chance do they have to become productive citizens of our county?
 - c. 26 instructional assistants (aides) these may be the most important part of the county staff. They assist the teachers, not with the top students, but with the students who need the most help. They are paid \$15,700 per year (\$9.50 per hour based on 7.5 hour workdays and a 220 day year). \$9.50 an hour to help with the kids who need the most help. The work doesn't stop at 7.5 hours. These kids become a part of their life.. they think about them at morning, day and night.
- 3. I didn't address Jordan Springs Elementary. Dr. Sovine is simply asking to staff a school that you already agreed to fund. Not staffing a brand new school would be like giving someone a brand new BMW, but not including the wheels because it wasn't in the budget.

I'm not here for personal gain. My kids would not go to Jordan Springs. My wife (who is an aide at NREP) would not benefit from the pay increase. I'm here because I'm a resident of Frederick County, with some of the lowest property taxes in Virginia, and I'm willing to give a little bit in taxes so the future of Frederick County want to come back and make this place special.

I wanted to send a comment for the Frederick County Budget Public hearing.

We greatly appreciate your support to the Fire and Rescue System. I wanted to make known to you my thoughts on keeping the Volunteer Budget request intact this year. We know the funds allocated to the Volunteer Companies (their budget) is a part of the Fire and Rescue Department budget. In fact, we have worked very hard to become the Fire and Rescue System. We don't want to be known as "Volunteer" and "Staff". So, any funds allocated to the Department are greatly appreciated. The greater part of the recent department budgets has focused on increasing staff to meet the current call volume. As well as providing individual equipment for the staff. With that said there are 11 Volunteer companies, each with unique challenges. Some have volunteers to respond to calls, some have volunteers to help with fundraising. The majority of Volunteer companies do not have enough volunteers of each category. Most Volunteer companies can be financially self-sufficient, with their own fundraising, for day to day expenses, until they must replace a piece of equipment. The Volunteer companies have operated mostly on a flat line of funding from the county for the past 8 years. That support funding and individual fund-raising efforts do not leave much cushion to offset from a Volunteer companies' day to day expenses to replace an ambulance (\$300,000) or fire truck (\$650,000). The support we ask for this year will help with day to day expenses while allowing for a cushion to be able to purchase new equipment or at least to secure a new equipment loan.
