#### ***IV-E RATE BREAKDOWN FOR BERRYVILLE PSYCHIATRIC RESIDENTIAL FACILITY***

**Room and Board (\$111.00 daily)** – includes semi-private room, 3 meals and 2 snacks per day, and personal care items.

**Daily Supervision (\$181.00)** - a resident to staff ratio as required by DBHDS, 1:4 awake hours and 1:6 sleeping hours, with documented supervision checks every 15-minutes.

**Supplemental Therapies (including Internal Case Management) (\$92.00)** also referred to as “21 Interventions” billed to Virginia Medicaid.

**Medical Counseling (\$39.00)** to include 24-hour nursing staff billed to Virginia Medicaid.

The total combined rate for the Berryville PRT is \$423.00 per day and this amount agrees with our rates with Virginia CSA’s.

**Cost billed to Medicaid – Supplemental Therapies (\$92.00) + Medical Counseling (\$39.00) = \$131.00**

**Cost billed to Agency – Room and Board (\$111.00) + Daily Supervision (\$181.00) = \$292.00**

#### ***IV-E RATE BREAKDOWN FOR RESIDENTIAL GROUP HOMES***

**Room and Board (\$73.00 daily)** – includes semi-private room, 3 meals and 2 snacks per day, and personal care items.

**Daily Supervision (\$290.00)** - a resident to staff ratio as required by DBHDS, 1:4 awake hours and 1:6 sleeping hours, with documented supervision checks every 15-minutes.

**Supplemental Therapies (including Internal Case Management) (\$41.00)** also referred to as “7 Interventions” billed to Virginia Medicaid.

**Medical Counseling (\$26.00)** to include 24-hour nursing staff billed to Virginia Medicaid.

The total combined charge rate for the Group Homes is \$430.00 per day and this amount agrees to our contract with DMAS EPSDT and our charge rates with Virginia CSA’s.

**Cost billed to Medicaid – Supplemental Therapies (\$41.00) + Medical Counseling (\$26.00) = \$67.00**

**Cost billed to Agency – Room and Board (\$73.00) + Daily Supervision (\$290.00) = \$363.00**
