RE: Notice of Amendment to Rates for Services for FY2022

On March 30th and 31st, NCG sent out our FY2022 Rate Sheets to all our CSA partners to provide advance notice of slight adjustments in our fee structure. Since that time, it has come to our attention that Virginia has established standardized rates statewide for several evidence based programs we provide, which are supported by the Family First Prevention Services Act, an initiative of the Virginia Department of Social Services.

Please be advised, <u>effective July 1, 2021</u>, National Counseling Group, Inc. is adopting the new rates for evidence based programs recently established through Family First funding. This letter is to document the revision of our FY2022 Rate Sheet to reflect the changes below:
