<sup>4</sup> UMFS allows for two nights of Pre-Placement in Treatment Foster Care at no cost. The listed rate applies to Pre-Placement beyond two nights.

<sup>5</sup> There are 10 days of Respite placement (Day or Overnight) built into the TFC enrollment. This rate applies for Respite placements (Day or Overnight) in excess of 10 days for an individual enrolled in TFC.

<sup>6</sup> Overnight Respite includes daytime hours during the placement. The rate is based on the number of nights the child is in the respite home.

<sup>7</sup> Children and youth served in Kinship TFC are those with treatment needs who are placed in out of home care with family members or fictive kin. Access to the full array of training, services, and supports available through treatment foster care are provided to promote safety, stability, and permanency.
