- A diagram of the sale location or area. The diagram is not required to be to scale. Indoor sales
  locations must show the locations from which the sales display will be observed. Outdoor sales
  must show the location of significant buildings, highways, sidewalks, and utilities (with an indicated
  distance in feet)
- Proof of corporate surety bond or a public liability insurance policy in an amount not less than \$1,000,000,000, naming Frederick County as an additional insured. Issuer must be licensed to do business in Virginia.
- Processing fee of \$200

Itinerant vendors must also provide the following:

- · Authorization letter from landowner(s) for retail fireworks sales
- · Copy of their current business license
- Zoning approval, if applicable

## By my signature:

- I attest that the supplied information is accurate and correct.
- I acknowledge and agree to comply with all applicable requirements of the Frederick County Fire Marshal's
  Office, to include the Frederick County Fire Prevention Code and it's referenced standards governing the
  use, storage, sales, and disposal of fireworks.
- I also acknowledge that if a permit is issued based upon this application, it shall be valid only at the location listed on the application, and for the specific dates and times for which it is issued.

If approved for permit issuance, I attest that a copy of this application and all its attachments will be available at all times. I further acknowledge and understand that any Frederick County Fire Prevention Code violations identified after permit issuance may result in immediate permit suspension or revocation.
