People Places Service Descriptions

Maintenance: Basic 0-4 yrs. Age-related payments made on behalf of a child age 0-4 to cover the cost of (and the cost of providing) food, clothing, shelter, daily supervision, school supplies, personal incidentals, as established by VDSS.

Maintenance: Basic 5-12 yrs. Age-related payments made on behalf of a child age 5-12 to cover the cost of (and the cost of providing) food, clothing, shelter, daily supervision, school supplies, personal incidentals, as established by VDSS.

Maintenance: Basic 13+ yrs. Age related payments made on behalf of a youth age 13+ to cover the cost of (and the cost of providing) food, clothing, shelter, daily supervision, school supplies, personal incidentals, as established by VDSS.

Maintenance: Enhanced: Payment made to foster parent(s) over and above the basic age-related foster care Basic Maintenance payment. This amount is based on the needs of the child for additional supervision and support by the foster parent(s) as determined by the VEMAT.

Maintenance: Independent Living: Payment made to foster care youth who are in Independent Living arrangements as determined by VDSS.

Maintenance: Client's Infant/Dependent: Payments made to support infants who remain in the custody of a Foster Care client. For infants who are in the custody of social services and placed in a People Places home, all individual placement rates apply for infant.

Maintenance: Clothing Supplement: Payments as determined and scheduled by VDSS for clothing outside of basic maintenance for children in foster care.

Maintenance: Child Care Assistance: Child care payments for daily supervision during the foster parent's working hours when child is not in school, or facilitates the foster parent(s) attendance at activities which are beyond the scope of ordinary parental duties, and is provided in a licensed day care facility or home.

Maintenance: Transportation: Payments made to support a child/youth in foster care in accordance with IV-E regulations, to include: visit to family including parents, relatives and siblings. The cost for the child/youth to be transported to a non-resident school in accordance with a best interest determination. These may be contracted services, cost of the actual mode of transportation, or mileage at the state rate for a driver to transport.

Maintenance: Pre-Placement or Trial-Placement Visits: Pre-placement Visits: Basic and Enhanced Maintenance payments made on behalf of a child to cover the cost of (and the cost of providing) food, clothing, shelter, daily supervision, school supplies, personal incidentals, as established by VDSS, during a trial-placement or pre-placement period. Up to four days of pre-placement are provided at no cost.

Private Foster Care: TFC Assessment Level: Upon admission to People Places all children/youth will enter at the Assessment level for a period not to exceed 60 days. A needs assessment and service plan will be completed based on all available information, documentation, observations and in collaboration with the LDSS, FAPT, foster family, birth family, and any other involved service providers. LDSS will complete the CANS and VEMAT during this period, and a Family Partnership Meeting may be held. The preferred funding source for TFC Case Management is DMAS. When a client is eligible, \$326.50/month will be billed to Medicaid; when ineligible \$326.50 will be billed to FAPT. A consensus will be reached collaboratively with a recommendation of the appropriate level of care for the specific needs of the youth. A minimum of two home visits per month or more as dictated by the needs of the youth, will be provided. 24/7 crisis intervention and support for the youth and foster family is provided.

Private Foster Care: Non-Treatment Level: A supportive level of service offered to foster parents to provide a structured and supportive setting to youth who are placed who have been assessed and do not present with treatment needs. This is intended as a lower level of support, while still maintaining quality foster care service, support, and supervision until a more permanent goal is achieved. These children should be developmentally on target, demonstrate age appropriate behaviors, participate in community activities without restriction, have no active diagnoses, and have minimal life domain/emotional/behavior needs, or be the sibling of a child who meets the criteria for TFC placement in the same home. This service will provide a lower level of contact than a TFC case, to include a minimum of one home visit per month and will include 24/7 crisis intervention as needed.

Private Foster Care: TFC Level 1: Core Treatment Foster Care services provided to children with a mild level of social/emotional/behavioral/medical/personal care needs or impairment for normal range of age and development; such as, but not limited to depression, anxiety, impulsivity, hyperactivity, anger control, adjustment to trauma, oppositional, substance use, eating disorder, physical health condition, developmental delay, or intellectual. Identification of IL goals for youth 14 and older and assistance to youth 16 and older with preparation for the transition from foster care to adulthood is included in this service. The youth's needs require monitoring or may require provision of services to decrease the likelihood that the needs will re-emerge. The preferred funding source for TFC Case Management is DMAS. When a client is eligible, \$326.50/month will be billed to Medicaid; when ineligible \$326.50 will be billed to FAPT. A minimum of one home visit per month and one face-to-face contact will be provided. 24/7 crisis intervention and support for the youth and foster family is provided. A youth may be stepped down to Level 1 upon achievement of permanency if behaviors have stabilized over a period of time. Step-down decisions are made with the treatment team in relation to permanency and stability.

Private Foster Care: TFC Level 2: Core Treatment Foster Care services provided to children with a moderate level of social/emotional/behavioral/medical/personal care needs or impairment for normal range of age and development; such as, but not limited to depression, anxiety, impulsivity, hyperactivity, anger control, adjustment to trauma, oppositional, substance use, eating disorder, physical health condition, developmental delay or intellectual. Identification of IL goals for youth 14 and older and assistance to youth 16 and older with preparation for the transition from foster care to adulthood is included in this service. The youth's needs require that action, interventions, services or supports be provided to address or remedy the needs. These services and available resources support and foster the placement, and include, but are not limited to, additional visitation or reunification work, case aide duties, and groups. The preferred funding source for TFC Case Management is DMAS. When a client is eligible, \$326.50/month will be billed to Medicaid; when ineligible \$326.50 will be billed to FAPT. 24/7 crisis intervention and support for the youth and foster family is provided.

Private Foster Care: TFC Level 3: Core Treatment Foster Care services provided to children who demonstrate a significant or severe level of social/emotional/behavioral/medical/personal care needs or impairment for normal range of age and development; such as, but not limited to depression, anxiety, impulsivity, hyperactivity, anger control, adjustment to trauma, oppositional, substance use, eating disorder, physical health condition, developmental delay, or intellectual. Identification of IL goals for youth 14 and older and assistance to youth 16 and older with preparation for the transition from foster care to adulthood is included in this service. The youth's needs are of such severity that they require intensive action, intervention, services, or supports to address or remedy the needs. A youth served at this level may be at risk for residential placement. These services and available resources support and foster the placement, and include, but are not limited to, additional visitation or reunification work, case aide duties, groups, and family-focused attachment and trauma work if the placement is at risk of disruption or the need exists for a higher level of care. The preferred funding source for TFC Case Management is DMAS. When a client is eligible, \$326.50/month will be billed to Medicaid; when ineligible \$326.50 will be billed to FAPT. 24/7 crisis intervention and support for the youth and foster family is provided. A minimum of two home visits per month or more as dictated by the needs of the youth will be provided.

TFC-Case Management: Medicaid: This DMAS defined service is a required component of TFC that focuses on continuity of services that are goal directed and results-oriented, and case management includes gaining access to needed medical, social, educational and other identified services developed in the individual treatment plan. It covers assessment, planning, referral and monitoring of services. It does not cover direct delivery of services, recruitment and approval of foster parents, their training, staff training, client placement, foster parent support, supervision and other service components of TFC. This service is combined with the appropriate level of Private Foster Care Support, Supervision and Administration-Supervision & Support described above.

TFC-Case Management: FAPT: This DMAS defined service is a required component of TFC that focuses on continuity of services that are goal directed and results-oriented, and case management includes gaining access to needed medical, social, educational and other identified services developed in the individual treatment plan. It covers assessment, planning, referral and monitoring of services. It does not cover direct delivery of services, recruitment and approval of foster parents, their training, staff training, client placement, foster parent support, supervision and other service components of TFC. This service is combined with the appropriate level of Private Foster Care Support, Supervision and Administration-Supervision & Support described above.

Private Foster Care: Supervised Visits: Supervision of additional or excessive family visitation between foster child and family members. Hourly billing based on the amount of staff time involved when there is a need for a more rigorous visitation schedule.

Private Foster Care: Clinical Visits: Supervision of family visitation between foster child and family members where the supervision requires observation, documentation, and possibility of court testimony by a qualified staff.

Family Support Service PostAdoption Level 1: This level of support and case management assistance provides work with a family who has adopted a special needs child, in order to prevent dissolution or placement outside of the adoptive home. It is intended for children or youth who have experienced complex-developmental trauma. On-call is provided, but respite nights are not part of this service.

Family Support Service PostAdoption Level 2: This level of support and case management assistance provides more intensive work with a family who has adopted a special needs child, in order to prevent dissolution or placement outside of the adoptive home. It is intended for children or youth who have experienced significant complex-developmental trauma. On-call is provided, but respite nights are not part of this service. This level may be at risk of disruption.

Family Support Service PostAdoption Level 3: This level of support and case management assistance provides the most intensive work with a family who has adopted a special needs child, in order to prevent dissolution or placement outside of the adoptive home. It is intended for children or youth who have experienced significant complex-developmental trauma. On-call is provided, but respite nights are not part of this service. This level may be at risk of disruption.

Family Support Service Family Mentoring: Community based service that provides skilled mentors trained and supervised in the teaching and modeling of practical parenting and family management skills.

Family Support Service Family Check-Up: The Family Check-Up® model is a brief, strengths-based intervention for families with children ages 2 through 17. The intervention aims to improve parenting skills and family management practices, with the goals of improving a range of emotional, behavioral and academic child outcomes.

Family Support Service Supervised Visits: Provides supervision of family visits for children/youth and their families. These are community referrals and do not include children who are placed in People Places foster homes.

Family Support Service Clinical Visits: Provides supervision of family visits which require clinical observation. Includes reporting, documentation and possibility of court testimony. These are community referrals and do not include children who are placed in People Places foster homes.

IL Service: Mentoring: A non-placement service which provides skilled mentors specializing in the support of young adults currently residing in independent living arrangements/situations in the community.

Therapeutic Groups: People Places Inc. offers clinical and psychoeducational groups which are designed to utilize the group process to support clients in healing from trauma and learning skills which will serve them in developing and maintaining significant relationships. Clients are assessed and assigned to groups based on individual needs. Groups provide a safe space for clients to process and work through their own unique struggles with others who have had similar life experiences.

Individualized Support Case Conferencing: Service to be used in conjunction with services and delivered at the request of referral agent and others as appropriate.

Private Day School: Special Education Tuition and Supplies: Intensive self-contained special education day school program. Individualized instruction includes but is not limited to academics, social-emotional learning, activities of daily living, and behavior reduction strategies. Staff to student ratio is 1:3 or higher based on students' individualized needs. Liaison maintained with public school and youth's family.

Private Day School: Autism Education Tuition and Supplies: Intensive, self-contained Applied Behavior Analytic (ABA) day school program. Individualized instruction includes but is not limited to communication skills, activities of daily living, pre-academic and academic concepts, social skills instruction, and behavior reduction. Staff to student ratio is 1:2 or higher as needed based on students' individualized needs. Liaison maintained with public school and youth's family.

Private Day School: Special Education Summer School: Intensive self-contained special education summer day school program. Individualized instruction includes but is not limited to academics, social-emotional learning, activities of daily living, and behavior reduction strategies. Staff to student ratio is 1:3 or higher based students' individualized needs. Liaison maintained with public school and youth's family.

Private Day School: Autism Education Summer School: Intensive, self-contained Applied Behavior Analytic (ABA) day school program. Individualized instruction includes but is not limited to communication skills, activities of daily living, pre-academic and academic concepts, social skills instruction, and behavior reduction. Staff to student ratio is 1:2 or higher as needed based on students' individualized needs. Liaison maintained with public school and youth's family.

Private Day School: 1:1 Aide: 1:1 Aides provide intensive supervision to maintain the student's placement as well as to help the student be able to meet classroom expectations both academically and behaviorally. The goal is to gradually increase the amount of time the student can work independently in the classroom. Data is kept by the Aide on the amount of time spent with the student.

Private Day School: Transition Tuition and Supplies: Enrollment in Pygmalion's private day school, intensive self-contained classroom setting during the period in which they are transitioning from the private day school back to their home school setting. A systematic transition plan and timeline will be decided on by the student's IEP team, with the intention of fading out their time in the private day school setting and increasing their time in the public school setting.

Private Day School: Transition 1:1 Aide: All students transitioning back to public school will be accompanied by a 1:1 aide whose primary role will be to assist the student in meeting the expectations of the new school environment (academically and behaviorally). The goal is to systematically decrease the number of hours of 1:1 service time so the student is working toward being fully independent in the classroom by the end of the agreed-upon transition period.

Private Day School: Behavior Analytic Consultation: This service includes consultative services provided by a BCBA or BCaBA which include behavior analytic assessments, development of treatment plans, and/or training of school staff (administrators, teachers, paraprofessionals, related service providers), community organizations, or parents, individual student or class-wide consultation.

Therapeutic Mentoring: Provision of one-to-one supervision to children or youth requiring more intensive individual guidance to successfully adjust in the foster home setting, school, or community, while supporting and reinforcing identified treatment goals.

Transportation: Transportation to support attainment of the goals in a child's service plan, either through contracted services or payment of mileage. Services may be designed to enable a child or family member to attend counseling, parenting classes, court, visitation with family members, or other appointments.

Outpatient Service Individual Counseling: Individual therapy provided or supervised by licensed counselors/therapists/psychologist including work related specifically to trauma and neglect.

Outpatient Services Family Counseling: Family therapy provided or supervised by licensed counselor/therapist/psychologist to include relationship-focused psychotherapy for family members in which the adults with whom the child resides are present and active in the treatment. Therapy focuses on parent training with goals of emotional development and related repair, for children with complex trauma/neglect or with attachment disorganization.

Other: A unique service that will ensure the safety and well-being of a child in an out of home placement, prevent disruption of the current placement, or enhance reunification efforts.
