

Patrol Division

Total calls for service in 2024 was 92,569. There were 7,162 warrants served, 3,416 criminal arrests, 5,862 traffic summonses issued, and 5,492 incident reports written.



Criminal Investigations Division

The Criminal Investigation Division investigated a total of 358 criminal cases in 2024.

The Civil Division served 14,830 civil papers and completed 887 extraditions/prisoner transports in 2024.

School Division

The Sheriff's Office provides school resource officers to Frederick County Public Schools. SROs received 6,018 calls for service in the 2023/24 school year where they completed 657 incident reports.

LICENSE PLATE READER (LPR) SYSTEMS

License plate reader (LPR) is a technology that uses cameras and software to capture and read license plate information, including characters and numbers.

The cameras are often mounted on vehicles, poles, walls and vehicle entry barriers, which allows the LPR systems to automatically capture license plate numbers that come into view, along with the date, time and location information. This license plate recognition data, including photographs of the vehicle and its occupants, is then uploaded to the system's server for record-keeping and further action if needed.

They are used to recover stolen vehicles, stolen license plates, locate wanted persons, and aid in criminal investigations. Data is entered into the system and the system then notifies the deputy if the data is scanned.

For example, Frederick County Sheriff's Office takes a report of a stolen vehicle. The stolen vehicle's information is entered into the LPR system. If a deputy's LPR passes the stolen vehicle, the LPR will set off an alert telling the deputy they just passed a stolen vehicle. The LPR alerts only on data entered in the system.

The LPR does not identify people by reading the vehicle's registration. A deputy would have to retrieve the registration from the LPR server and then check the registration through DMV to identify the vehicle's owner. Deputy's must have a criminal justice purpose to check any vehicle's registration through DMV.
