<b>SERVICE</b>	<b>RATE</b>
<b>FORENSIC SERVICES PROVIDED IN-OFFICE OR OF-SITE</b> This would include services rendered for any court involved or court ordered evaluation case to include court ordered psychological evaluations, risk assessments, and parental fitness evaluations. All parts of the assessment are billed at this rate meaning interviews, testing, report preparation, observation, feedback, etc. This rate would also be billed for testimony preparation and court appearances if required.	<b>\$300/hr</b>
<b>CLINICAL EVALUATION SERVICES PROVIDED IN-OFFICE OR OF-SITE</b> This would include psychological and psychoeducational evaluations that are not court involved. All services for the evaluation would be billed at this rate to include interviews, psychological testing, observations, report preparation, feedback, etc.	<b>\$200/hr</b>
<b>THERAPY SERVICES</b> All therapy services including court ordered or court involved therapy are billed at this rate (for 55 minute sessions).	<b>\$200/hr</b>
