I. CALL TO ORDER

Chairman Tibbs called the meeting to order at 10:00 a.m.

II. APPROVAL OF AGENDA

Chairman Tibbs solicited a motion to approve the agenda. A motion was made by Sheriff Millholland to approve the agenda. Ms. McCann-Slaughter seconded the motion. The Authority unanimously approved.

III. APPROVAL OF THE MINUTES FROM FEBRUARY 27, 2025

Chairman Tibbs solicited a motion to approve the minutes from the February 27, 2025, meeting. A correction needed to be made to page 3, section IV, third column, "Proposed FY25 Budget" needed to be corrected to read, "Proposed FY26 Budget". A motion was made by Sheriff Millholland to approve the minutes with the correction. Ms. McCann-Slaughter seconded the motion. The Authority unanimously approved.

Superintendent Corbin reported that the \$1.2M remaining balance in Personnel is due to the current vacancies, which is 15. Of those 15, 11 are sworn, but 4 of those 15 vacancies were frozen due to the salary adjustments that were given in February 2025.

The anticipated return to Fund Balance is \$1,947,929. The current Fund Balance is \$6,433,625 plus \$1,947,929 = \$8,381,554 - \$2,500,00 (for FY26 Budget) = \$5,881,554.

12% of FY26 budget = \$3,549,711.

VI. SUPERINTENDENT'S REPORT

Superintendent Corbin updated the Jail Authority on the DOC out-of-compliance for the last 3 months:

- February 76
- March − 65
- April 58

The current inmate population is 613. The HEM headcount is included in our total population.

Superintendent Corbin proposed that the inmate daily housing fee be increased from \$1.50 to \$2.00. It has been 9 years since it has increased. A motion was made by Sheriff Millholland to approve the increase. Ms. McCann-Slaughter seconded the motion. The Jail Authority unanimously approved.

Superintendent Corbin reported that our most senior Maintenance employee is retiring at the end of the year. Due to the volume of work orders maintenance receives, we felt that we should hire a new maintenance technician at least 6 months before he retires, so that the new person will be fully trained by the end of the year. We have temporarily renamed a vacant nurse position, which has been vacant since 2019, as a maintenance technician. This position will revert back to a nurse position January 1, 2026.

Superintendent Corbin reported that there has been a great benefit with the realignment of authority and wanted to thank the Jail Authority. A couple of those benefits that he has seen so far have been buying out contracts and the hiring of Certified Medication Aides.

Recently, Superintendent Corbin was asked to speak at Laurel Ridge Community College during their "Triumph over Trauma" summit to talk about the programs that we provide. Northwestern Regional Adult Detention Center has appeared on a podcast, and we have had visitors from Colorado and Florida prison to see what we are providing in programs.
