RE: AMI Gateway Collector Antenna Placement

Dear Ms. Herbaugh,

Frederick Water is advancing an initiative to enable water meters from Frederick Water's nearly 19,300 customer accounts to be read remotely. This Automated Metering Infrastructure (AMI) initiative requires the establishment of strategically placed gateway collector antennas throughout our service area. Preliminary evaluations indicate that placement of an AMI antenna in Sherando Park, Stonewall Park, and in the future Old Charlestown Road Park would support the AMI initiative. Frederick Water seeks to secure approval from the County to facilitate placement of the AMI Gateway Collector antennas on the park properties.

AMI technology will improve Frederick Water's ability to collect frequent and accurate water consumption data to improve billing, leak detection, and water resource management. The technology enables Frederick Water to remotely capture water meter reads as frequently as every 15 minutes. This remote read eliminates the current practice of driving past every customer water meter to capture monthly and bimonthly billing reads. More importantly, the technology enables water customers to register to receive text message and email alerts when water consumption at their residence or business trends higher than usual. This alert message will quickly inform the customer that their water is continuously running and warrants immediate attention. Leaky faucet or toilet. Continuously running water softener. Actual

broken water line. These are all issues that need immediate attention to eliminate water loss and unnecessary expense.

The AMI gateway collectors capture the consumption readings being pushed out by the water meters. Placing the gateway collector antenna on elevated, strategic locations maximize the read captures with the least number of collector antennas. The typical antenna is a 50-inch long 1-inch diameter white fiberglass rod and weighs less than 2-lbs. The gateway collector panel measures approximately 13x9x7 inches and weighs less than 30-lbs. The antenna is mounted at the highest point available; the control panel at a lower location that is more easily accessible. The unit draws less than 10 watts of power and requires an internet connection (cellular may be used if hardwire internet service is not available).

We look to identify and use existing elevated facilities. The first group of gateway collector antennas are being placed atop Frederick Water elevated water storage tanks. The antenna atop the Tasker Road elevated water tank captures reads from over 3,900 water meters! If location-appropriate existing elevated facilities are not available, we will default to placing antennas on wood poles (aka electrical utility poles) placed at Frederick Water's existing sanitary sewer pump stations. Photos of a pole placement examples are attached.

There are three parks and recreation sites for which we would request your consideration for placement of AMI antennas.

1. Sherando Park, Ballfield 5, outfield light pole, PIN #86-A-143C

This field is in Sherando Park, north of Fairfax Pike.

Request to co-locate on the existing ballfield 5 outfield light pole, east of the outfield. This pole location would facilitate access to new electrical and internet services. The antenna would be mounted on the light pole at the highest location without interfering with the ballfield light fixtures. The control panel would be mounted to the pole near ground level but above pedestrian reach, opposite side the from the field to shield from balls. See attached location illustrative.

2. Stonewall Park, Roper Field, infield light pole,

Request to co-locate on the existing ballfield infield light pole, south of the park's restroom/concession building. This pole location would facilitate access to existing electrical services; internet service would need to be established. The antenna would be mounted on the pole at the highest location without interfering with the ballfield

light fixtures. The control panel would be mounted to the pole near ground level but above pedestrian reach. See attached location illustrative.

3. Future Old Charlestown Road Park, 692 Old Charles Town Road, PIN #44-A-139
Request to install a wood pole (aka electrical utility pole) adjacent to the northern side of the existing storage building. The pole would be up to 70-ft tall. The unit could use existing electrical services or establish new electrical and internet service connections. See attached location illustrative.

With the County's support of the locations requested, we would propose that a 20-year renewable lease arrangement be utilized to document the agreement, and each party's expectations and responsibilities.






