Payment can be made: online at [www.fredtax.com](http://www.fredtax.com) OR at the Treasurer's Office (107 North Kent St) OR check made payable/sent to: Treasurer, PO Box 220, Winchester VA 22604.
- **NOTE:** Contractors will also need to provide additional information/documentation (**printable forms available at [www.fcva.us/biztax](http://www.fcva.us/biztax)**):
  - Workers Compensation Ins. form – see page 2 (State of VA requires annual filing even if no insurance required)
  - VA State Contractors License and VA Tradesmen License, if applicable (provide updated license numbers and expiration dates)
  - A Statement and Notarized Affidavit if not subject to licensure
  - A breakdown of Gross Receipts earned in other jurisdictions, if applicable
  - Copies of business licenses from other jurisdictions, if applicable
  - A list of subcontractors, if applicable
- A **Tangible Business Personal Property Return** for business equipment, tools and furnishings etc. (other than vehicles or trailers) owned as of January 1 is **DUE \*\*March 1\*\*/NEW DATE (or first business day thereafter)** on the applicable form (762B-Business Equipment, 762M-Manufacturing/M&T, and 762P-Processors).
