This fire and rescue apparatus will be assigned to Fire and Rescue Station 22 located on Fairfax Pike East in the Stephens City area of Frederick County. The pumper will be built to N.F.P.A. 1901 specifications and equipped with all of the required and necessary equipment to function as a Class A Pumper. The ambulance will be built to the Federal KKK-A-1822E specifications and equipped with all of the required and necessary equipment to function as an Advanced Life Support ambulance.

This fire and rescue apparatus is needed due to the fact that the Fire and Rescue Department currently owns one (1) pumper and one (1) ladder truck that are twenty (20) plus years of age and already assigned to other functions. The currently owned fire and rescue apparatus would not endure the demands placed on it while being assigned to a high call volume.

A two and ½ acre parcel should be sufficient for building, parking and amenities for approximately 20 to 30 persons.

Construct a Regional Public Safety Training Center potentially consisting of an administrative building, multi-story burn building, multi-story training tower, vehicle driving range, shooting range, and numerous other training props. This project will incorporate emergency medical services, fire, hazardous materials, rescue, law enforcement, industrial, and educational institutions located in Clarke County, Frederick County, Shenandoah County, Warren County, Winchester City, State Agencies, Federal Agencies, and potentially jurisdictions within the State of West Virginia.

The Training Center will be located in the area central to the region which is the Middletown area of Frederick County. This area will facilitate necessary access by all participating agencies and jurisdictions as well as be incorporated into the existing facilities of the Lord Fairfax Community College and the Rappahannock Regional Criminal Justice Academy – Middletown Campus. The Training Center will require between eighty (80) to one hundred (100) acres to facilitate the required buildings, associated props, and other training areas.

The determination for the exact buildings, associated props, and training areas will be determined by the agencies needs assessed by the Public Safety Training Center Questionnaire that was distributed in July 2007. The proposed Training Center will be developed in a phased approach based on the strategic needs of the Northern Shenandoah Valley Region. The exact size, square footage, and capacity of the buildings, associated props, and training areas will also be determined by the agencies as well as designed to meet the specifications of the regulatory authorities within the Commonwealth of Virginia.

**Project Justification:**

This project will facilitate realistic training in today's modern environment for emergency services and industrial personnel located throughout the Northern Shenandoah Valley and expanding into the State of West Virginia. This project will reinforce existing training programs in those respective agencies and jurisdictions as well as facilitate training that is currently not available within the Northern Shenandoah Valley which causes students and instructors to travel into the Washington Metropolitan region. The number of potential personnel being trained at this Training Center is potentially in the thousands based upon training statistics provided in July 2007 by the participating agencies.

The Public Safety Training Center will take several years to complete due to the various identified needs within the proposal as well as seeking opportunities for grant funding from the available resources within the Commonwealth of Virginia and United States. The following is the proposed work schedule:

- Fiscal Year 2016/2017 – Meetings with agencies and jurisdictions to determine needs and participation.
- Fiscal Year 2016/2017 – Meetings with Commonwealth of Virginia Departments to determine available and/or potential funding sources to support project.
- Fiscal Year 2016/2017 – Meet with third party organizations to assist with the Strategic Planning process for this project.
- Fiscal Year 2017/2018 – Continue to meet with various third party organizations to develop and facilitate the Strategic Plan. Committee will begin to determine basic design concepts and designs of buildings, associated props, and training areas to forward to the third party organization.
- Fiscal Year 2017/2018 – Hire a third party organization to develop and facilitate the Strategic Plan. Develop a “Request for Proposal” to hire a third party architectural firm to design the buildings, associated props, and training areas.
- Fiscal Year 2018/2019 – Hire a third party architectural firm to design buildings, props, and training areas.
- Fiscal Year 2018/2019 – Purchase land to facilitate the Training Center.
- Fiscal Year 2018/2019 – Begin construction of Phase I of the project.
- Fiscal Year 2019/2020 – Begin construction of Phase II of the project.
- Fiscal Year 2020/2021 – Begin construction of Phase III of the project.
- Fiscal Year 2020/2021 – Project completion.

This project will greatly improve the capabilities of emergency responders (local, state, and federal) and industrial facilities in the Northern Shenandoah Valley to respond to all types of incidents in a safe, effective, and efficient manner. This project will have a positive impact on the health, safety, and welfare of our emergency responders as well as our citizen's and visitors.

During the next ten (10) years, the Northern Shenandoah Valley is expected to grow immensely due to people relocating from the Washington Metropolitan area as well as the creation of additional employment opportunities within the region. With the increased diversified population, increased number and type of residential complexes, increased number and type of commercial complexes, increased industrial complexes, increased number of incident responses, increased training requirements of emergency services personnel, and mandated requirements for governments throughout the region, the amount of education and training needed to facilitate these changes will require the need for this facility to meet the demands.
